### ● DISCOUNT CODE RULES

✓ **Public promo codes (e.g. EID10, SUMMER20)**  
Share freely — no restrictions

✓ **Your personal affiliate code**  
Share on your own channels anytime

✗ **Internal dynamic codes (DCW-series)**  
Private customer codes — never share. Violation = immediate suspension.

### ● KEY RULES AT A GLANCE

- ✓ Boost your own social posts — always allowed
- ✓ Write honest blog reviews & YouTube content
- ✓ Use #ad or #affiliate on all affiliate content (legal requirement)
- ✓ Run non-brand keyword ads after email approval
- ✗ Never bid on brand keywords — "Mariam", "mariam-col.com"
- ✗ Never register a domain containing "Mariam"
- ✗ No self-purchases using your own affiliate link
- ✗ One account per person — no duplicate accounts
